I, the undersigned, declare that

1. the information given in this application form is true and correct;
2. I, as parent/guardian, take cognisance of the school's rules and admission policy and undertake to support the school in the education of our child and ensure that he/she complies strictly and unconditionally too the rules and customs as laid down by the school.
3. The school fees/tuition fees, (as set out above), with regards to an academic year, are payable in advance, (as set out above), unless alternative arrangements have been made with the school (bursar) for the payment thereof on either a monthly basis.
4. If alternative arrangements are made by the parent(s)/guardian with regards to either a monthly plan, the parent(s)/guardian agree and undertake to effect such payment(s) on due and agreed date, failing which, the full outstanding balance will be due and payable with immediate effect.
5. In terms of Family law parents are *jointly and severally* liable for the payment of learners fees.
6. In the event of non payment, action will be taken against *BOTH* parents regardless of any maintenance agreements which may exist between the parties.
7. In terms of section 39, 40 and 41 if the South African Schools act parents are liable for compulsory school fees and the school may enforce the payment of school fee.
8. The parent(s)/guardian consent to the jurisdiction of the Magistrate Court Act 32 of 1944, as amended.
9. In the event of legal action being instituted in order to collect arrear school fees, the parent(s)/guardian agree to and accept liability for the payment of the following:
 - Legal costs on the scale as between attorney and client;
 - Interest at the rate per annum as from date of outstanding amount being due and payable until date of final payment; and
 - Collection commission at the rate of 22.8%.
10. The school may conduct a credit enquiry and/or a credit information search about the parent/s with a credit information bureau, persons acting as their agents and/or other credit grantors.
11. Debit orders are on the first day of each month from 1 March 2012 – 1 November 2012, with either a double debit order on 1 March 2012 or alternatively a cash payment before 7 February 2012. First monthly payment for 1 February 2012 are only accepted till 7 February 2012.
